Responding to Federal Attacks

In response to mass firings of federal workers, we collaborated with partners to build the **Federal Workers Legal Defense Network**. We launched the **Worker Policy Watch** to monitor policy changes and share reliable information with advocates. NELP supported worker organizations navigating immigration enforcement actions at worksites and in communities.

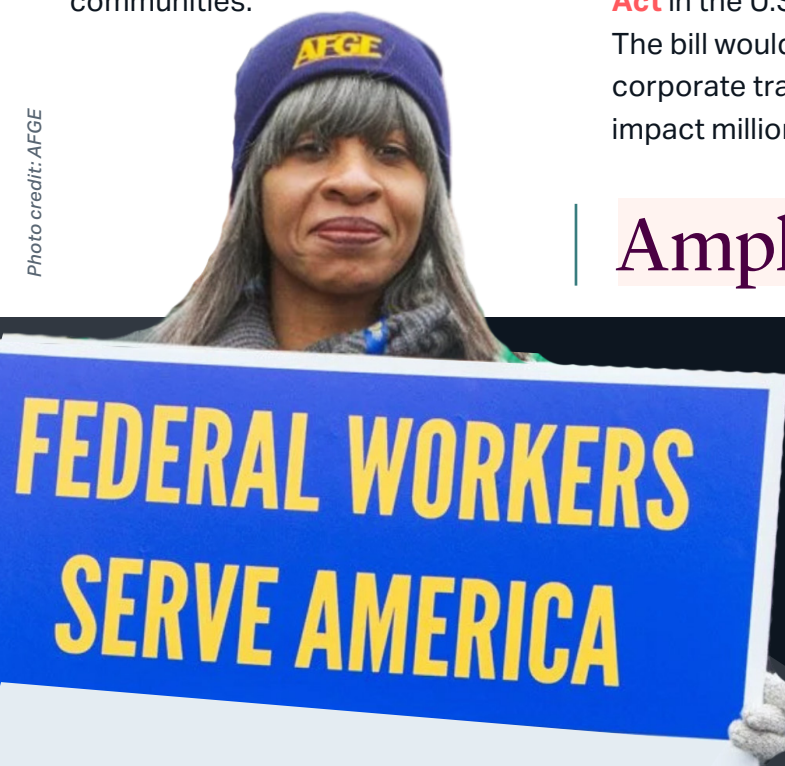

Advancing Contracted Worker Justice & Corporate Accountability

NELP was a key partner in driver and delivery worker pay standard campaigns in Connecticut, Oregon, and New York City. We exposed corporate technology abuses in two groundbreaking reports, **When 'Bossware' Manages Workers** and **Delivering Precarity**, and led efforts to secure the introduction of the **Empowering App-Based Workers Act** in the U.S. House and Senate. The bill would require increased corporate transparency and impact millions of workers.

Raising Wages

We supported minimum wage campaigns in 6 states and localities and will continue to **advance bold living wage campaigns** over the next several years. With the ongoing and worsening cost-of-living crisis, the need for states to move above a \$15 minimum wage is urgent. NELP also filed extensive comments opposing the federal rollback of homecare worker wage and overtime protections in coordination with allies.

Amplifying worker voices

NELP's **Worker Voices series** features firsthand stories of workers and the courageous ways they're organizing to improve workplaces across the country.

Strengthening Unemployment Insurance

We made significant progress with our unemployment insurance reform advocacy. In Virginia, we led a coalition to increase the UI benefit amount by \$52 a week for 4 million workers and helped expand UI to Amazon Flex workers. Additionally, we supported successful state campaigns in Washington and Oregon to secure UI for striking workers.

Building Capacity with Worker Centers

We partnered with over 75 worker centers, strengthening a resilient ecosystem of movement organizations. We provided tailored legal and technical assistance, risk assessment, and convened spaces for peer learning. In addition to protecting worker centers from immediate threats, we supported organizational development, enhanced worker organizing through multi-entity structures, helped advance affirmative campaigns addressing issues in the restaurant and construction industries, and bolstered collaboration between worker organizations and state labor agencies.

Advocating for Safe Workplaces

As climate change increasingly endangers worker safety across the country, we advocated alongside **worker and environmental organizations** in 9 states for workplace heat standards. We also supported the implementation and enforcement of the Warehouse Worker Injury Reduction Act in New York to keep warehouse workers safe.

Fighting Workplace Discrimination

NELP worked closely with allies to strengthen Washington's fair chance hiring law, impacting the 1.3 million people estimated to have conviction or arrest records in that state. To understand and amplify retail worker experiences, **we surveyed more than 200 workers** across 10 unionized REI stores, with workers sharing examples of racial discrimination and inequities across the company.

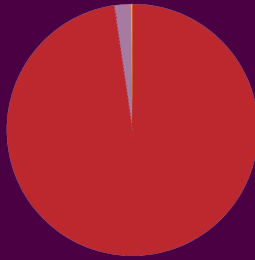

Total: \$6,271,513



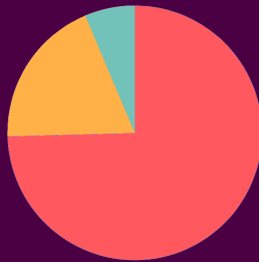
Expenses
