WHEREAS, the United States as a result of its "War on Drugs" has one of the highest rates and levels of felony and misdemeanor convictions; and

WHEREAS, these convictions are often for nonviolent crimes; and

WHEREAS, removing the questions cited above does not compromise the health, safety and welfare of the people of the City of Kingston, New York.
